BALLOT MEASURES

INITIATIVE 1631 NO

Concerns pollution. To impose a state carbon tax on energy use in Washington State.

INITIATIVE 1634 NO

Concerns taxation of certain items intended for human consumption. To relinquish local control of taxes on food items.

INITIATIVE 1639 NO

Concerns firearms. To enact new restrictions on firearms ownership in Washington state.

INITIATIVE 940 NO

Concerns law enforcement. To require more law enforcement training and to increase police officer liability on the use of deadly force.

ADVISORY VOTE 19 REPEALED

The legislature expanded the oil spill response and administration taxes to crude oil or petroleum products received by pipeline.
